

ESTATE PLANNING WITH NATURAL LANDS SUGGESTED LEGAL LANGUAGE

BEQUESTS

We encourage you to consult with an attorney to decide which of these varied forms of bequests is appropriate for your circumstances and to assist you in coordinating your gift as part of your overall tax and estate planning.

RESIDUARY BEQUEST

After specific gifts to loved ones are made and after taxes and expenses are paid, you may leave a percentage (or all) of your net estate to Natural Lands.

SPECIFIC BEQUEST
